- Clear, repopulate and recorrelate the investment, loan and deposit correlation tables.
- Review and revise, the investment, loan and deposit sections of the GL correlation and distribution tables.
- Testing of the Databridge interface with month-end extract files, balancing back to the previously updated month-end financials.


